

## Quarterly Public Reporting for HEERF I, II, III (a)(1) and (a)(4) Student Aid Portion

The Federal government enacted the HEERF I grants under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), HEERF II grants under the 2021 Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA, Section 314 of the Consolidated Appropriations Act, 2021) and HEERF III grants under the American Rescue Plan Act of 2021 (ARP) section (a)(1) and (a)(4) programs to make Emergency Financial Aid Grants to Students for expenses related to the disruption of campus operations due to coronavirus, including eligible expenses under the student's cost of attendance, such as food, course materials, technology, health care, and child care. The law requires institutions to report certain information related to the use of these funds.

The following information is reported for the period October 1, 2021 to December 31, 2021.

- I. This statement shall serve to acknowledge that our institution signed and returned to the US Department of Education the *Certification and Agreement – Emergency Financial Aid Grants to Students*: We further attest that our institution has used, and/or intends to use the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.
- II. The total amount of funds that the institution has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students is **\$526,949.00**.
- III. The total amount of Emergency Financial Aid Grants distributed to students under CRRSAA and ARP (a)(1) and (a)(4) programs as of December 31, 2021 is \$6,600.
- IV. The estimated total number of students at our institution eligible to participate in programs under Section 484 of Title IV of the Higher Education Act of 1965 and who are eligible to receive Emergency Financial Aid Grants under the CRRSAA and ARP (a)(1) and (a)(4) programs is 100 students.
- V. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs to date is < then 10 students have received a grant.

## Attachment A

Policies and Procedures Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act and the Coronavirus Response and Relief Supplemental Appropriation Act, 2021 (CRRSAA), signed into law on December 27, 2020

Updated August 18, 2021

*On March 27, 2020, Congress authorized the US Department of Education to provide Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The funds provided to students through CARES and subsequent CRRSAA acts are for the disruption of campus operations due to coronavirus, such as food, housing, course materials, for any component of the student's cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, health care (including mental health care) or child-care.*

*Merkaz Bnos will be disbursing funds to enrolled students, prioritizes the **neediest of students**, based on the following criteria:*

- You must be eligible to receive Title IV Aid and/or New York State Tuition Assistance Program:  
This means you must be eligible to receive such as one or more of the following federal aid programs: Pell Grant, FSEOG, Direct Loan, Federal Work Study or a student may prove financial hardship via proof of receiving any Public Assistance such as Food stamps, Medicaid or unemployment benefits for a student or for a parent if the student is dependent.
- You must be actively enrolled in a Diploma or Certificate program at Merkaz Bnos at the time when you receive the grant.
- You must be a student at good standing as defined at the Merkaz Bnos catalog.
- Effective August 18, 2021 and thereafter the maximum award for the attending Full-time eligible students will be \$4,000. Eligible students, attending Merkaz Bnos on August 18, 2021, who received a lesser amount of only \$1,800, may be eligible to receive an additional award of \$2,200 (total of \$4,000). Or the amount requested by the student, on the special grant request form, whichever is less. This method of fund distribution will be used equally for all eligible students.
- These funds are a grant. They are not a loan and do not require to be paid back. These funds are also nontaxable for federal purposes.
- According to the US Department of Education, the funds shall not be used for any purpose other than the direct payment of grants to students for their expenses related to the disruption of regular campus operations due to coronavirus, such as food, housing, course materials, technology, health care, and child-care or as indicated on their request form. Therefore, students must inform Merkaz Bnos in writing to what purpose(s) the funds shall be used.
- Funds will be provided to students in the form of a check, and may be picked up by student or mailed out to the student via US Postal Service.
- Eligible students will be required to complete a special form requesting the funds and confirm the receipt of the grant.
  - o Confirmation on the special form includes that the student has been negatively impacted by COVID-19.
  - o Which of the allowable uses the student intends to use the funds for including (Food, Housing, Course materials, Technology and for any component of the student's cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, health care (including mental health care) or child-care.
  - o Correct spelling of the student's name.
  - o Mailing address - any errors in mailing address that result in a lost check may result in a bank related fee and/or delay on replacement funds.
- Up to a maximum of \$742,349 of the funds received may be available to be distributed to the eligible enrolled students affected by COVID-19.
- Student disbursements will be tracked using the CARES/HEERF Grant template and posted on the school website [www.mbs-career.org](http://www.mbs-career.org)
- A copy of the request for Emergency Financial Aid Grants Fund form will be maintained in the student file.

**The students will be informed about the policies concerning the CARES and CRRSAA Acts funds and receive the proper form through the college website [www.mbs-career.org](http://www.mbs-career.org) and/or via email. Once the necessary form is completed and received by the school, the funds will be distributed within 10 days.**
